

AMENDMENT

AMENDED AND RESTATED ARTICLES OF INCORPORATION OF

UNIVERSITY GROVES ESTATES RESERVE ASSOCIATION, INC.

(F/K/A TOWNHOUSE RESIDENCES AT UNIVERSITY GROVES ASSOCIATION, INC.)

[Additions are indicated by bold underline; deletions by strike-through]

ARTICLE 6 BOARD OF DIRECTORS

- 6.4 <u>Qualification and Term.</u> Directors need not be members of the Association. Directors appointed by the Class B member shall not serve fixed lerms, but shall serve at the pleasure of the Class B member. Except as may be otherwise required by the terms of Article 6.2, Directors elected pursuant to Article 6.3-shall be elected at the annual meeting of members and their term-shall expire at the next succeeding annual meeting of members. Commencing with the Turnover Meeting, except for persons appointed as Directors by the Class B member, no person shall serve as a Director for successive terms or more than two terms during any five year period.
- 6.4 Qualifications and Term. Directors must be members of the Association. Directors elected pursuant to Article 6.3 shall be elected at the annual meeting of members to serve a single two-year term. However, to impose staggered terms, the Directors that are re-elected following the effective date of this amendment who have already served a single term, shall only serve one (1) year term(s). Term limits shall be a single two (2) year term which must be followed by a minimum one (1) year absence from the Board of Directors. Service as a Director through appointment or as the result of election to the initial one-year term shall count towards term limits.

ARTICLE 7 OFFICERS

7.1 Number, Qualification and Term. The officers of the Association, to be elected by the Board of Directors at its organizational meeting following the annual meeting of the members of the Association, shall be a President, a Vice President, and a Secretary and such other officers as the Board of Directors shall deem appropriate from time to time. The officers of the Association shall be members of the Board of Directors. The President shall be elected from among the membership of the Board of Directors, but no other officer need be a Director. The same person may hold two or more offices, provided, however, that the office of President and Secretary shall not be held by the same person. The affairs of the Association shall be administered by such officers under the direction of the Board of Directors. Officers shall be elected at the annual meeting of the Board of Directors, and their term shall expire at the next succeeding annual meeting of the Board of Directors. Commencing with the Turnover Meeting, no person shall serve as an officer for successive terms or for more than two terms during any five year period.
