AMENDED AND RESTATED BYLAWS

OF

VILLA GARDENS OWNERS ASSOCIATION, INC., A Florida corporation, Not-for-Profit

ARTICLE VII - OFFICERS

7.06. Signing Authority. Only the President, or in the event the President is unable to act, the Vice President of the Association are authorized to sign documents and contracts on behalf of the Association except in to the extent that the Board of Directors has authorized a manager or other agent to sign such documents or contracts. In the case of checks for normal operating expenses, the board may authorize the property manager/accountant to utilize automated bill payment methods provided by the Association bank for payment of said expenses that are approved by the President and Treasurer of the Association or in the instance of Association checks, which shall require the signature of both the President and Treasurer, but in the absence of one or both of those Officers, by any other two Directors. It is the intent that all Association checks shall be signed by at least two persons as authorized herein.
